

PHIMC Presents at 2016 National Network of Public Health Institutes (NNPHI) Annual Conference

PHIMC shared expertise in cross-sector collaboration and program implementation during presentations on the Community Reentry Project (CRP), National Health Corps Chicago (NHC Chicago), and Protecting Our Patients (POP) at the 2016 National Network of Public Health Institutes conference in May. The conference brings together public health institutes and other stakeholders to discuss ways to improve population health and bridge sectors.

Executive Director Karen A. Reitan presented on CRP, focusing on the successful strategies that PHIMC uses to build alliances with the Illinois Department of Public Health, Illinois Department of Corrections, and a statewide network of partner agencies. These collaborations support the CRP's success providing coordinated services to improve the lives of



clients at high risk for HIV as they transition from incarceration to communities throughout Illinois.

Deputy Director - Programs, Jenny Epstein, presented a poster detailing NHC Chicago's commitment to fostering healthy communities and developing future health leaders. Through a comprehensive program model, NHC Chicago promotes health and wellness education, benefits, and services to communities in need.

In a roundtable discussion, Deputy Director - Strategy and Partnerships, Blair Harvey, shared how POP reduces stigmas that prevent healthy patient outcomes. The two POP interventions highlighted provide professionals with strategies for integrating HIV screening into routine health care and providing affirming medical care for all patients, especially marginalized populations.
