PHIMC Seeks New Routine HIV Screening Partner Agencies

PHIMC is seeking two new health care partners to continue our decade-long work supporting routine HIV screening in Illinois. These agencies will work with PHIMC staff to implement routine HIV screening into their clinical settings as a standard of care. Partners will receive training and technical assistance, funding for capacity building, support for billing and reimbursement of services, and access to a statewide network of other clinical settings doing the same work. Over the last three years of the project, clinical sites conducted over 69,000 tests, identified 389 positive cases, integrated screening into electronic health record systems, and established third party billing and reimbursement processes for testing.
