

Legal Resources in Illinois for Issues Dealing with HIV

Whether you are just starting to establish an HIV testing program at your location, or if you are expanding a current program, it is important to have a contact for legal questions which may arise. Persons living with HIV may face confidentiality issues or even discrimination. The following is a list of some of the legal resources available in Illinois. All HIV testing sites should establish cooperation with a local legal resource. The AIDS Legal Council of Chicago can assist you in starting this cooperation. It also has a toll free number in Illinois to answer any questions concerning HIV testing and the law.

A person's HIV status is confidential according to Illinois law, which means that almost no one can disclose another person's HIV status without permission from that person.

All of the organizations offer free consultations and legal advice. Having a relationship with one of these organizations will help you to help your clients with issues concerning HIV+ status and confidentiality after testing, discrimination, employment, immigration, benefits, and other issues.

Since April, 1995, PSLS has maintained the HIV/AIDS Legal Services Project to deliver legal assistance at no cost to persons who are HIV+ or who have AIDS. The financial eligibility criteria to qualify for Prairie State Legal Services help have been expanded for this project.

Eligible clients must document their medical serostatus, and be a resident in one of the PSLS counties where project services are available. The counties covered by PSLS are in the central to northern parts of Illinois. Call the number above to determine which local PSLS office can assist you.

Land of Lincoln is an Illinois not-for-profit corporation. It provides free civil legal services to low-income persons and senior citizens in 65 counties in central and southern Illinois. Its mission is to pursue civil justice for low-income persons through representation and education.

Land of Lincoln Legal Assistance Foundation has five regional offices, three satellite offices and a centralized telephone intake, advice and referral center called the Legal Advice & Referral Center (LARC). The regional offices are located in Alton, Champaign, Carbondale, East St. Louis and Springfield. The satellite offices are in Charleston, Decatur and Mt. Vernon.

While they do not have a specific HIV/AIDS "project", they are a good resource if you are living in central or southern Illinois. Call the LARC, and depending on what county you live in you will be given a local legal contact.
