In a surprise move during the January 26, 2020 reception to celebrate the union between Illinois Safe Schools Alliance (the Alliance) and Public Health Institute of Metropolitan Chicago (PHIMC), PHIMC Executive Director Karen A. Reitan presented the <u>Inaugural Mary F.</u> Morten Award for Justice to its namesake.

A nationally recognized advocate for equity and justice, Mary F. Morten is the President of Morten Group, LLC, a national consulting firm established in November 2001 to focus on clients in the nonprofit, for profit, and foundation fields. Mary is a founding member of the Alliance and will continue her leadership role by serving on the Board of Directors at PHIMC.

"The Institute has never given an award before, and we are excited to start by creating the Inaugural Mary F. Morten Award for Justice," said Karen, who spoke about Mary's leadership in shepherding the merger with PHIMC and noted how Mary's work over the years for diversity, equity, and inclusion has changed people's workplaces and people's lives all over the country.

SUD Allies participate in 2020 MLK Day of Service

PHIMC is excited to see the Substance Use Disorder (SUD) Allies team expand capacity for substance use disorder in Illinois communities. For the 2019-2020 service term, SUD Allies has five full-time members. Meghana Atre, David Ferreira-Hersh, and Agnes Park serve as Case Managers at Healthcare Alternative Systems; Tara Hartnett serves as a Substance Use Prevention Educator at Erie Family Health Center; and Okwuchi "Chi" Onwubu serves as a Health Educator at Lurie Children's Hospital.

Administered by PHIMC, SUD Allies is a state AmeriCorps program that supports substance use disorder prevention, treatment, and recovery services throughout Chicago and suburban Cook County.

National Health Corps Chicago

National Health Corps (NHC) fosters healthy communities by connecting those who need it most with health and wellness education, benefits, and services, while developing tomorrow's compassionate health leaders. In 2018-2019, services provided by NHC members in all four cities - Chicago, Philadelphia, Pittsburgh, and North Florida - resulted in:

- **164,211 new clients** receiving health education and accessing services in their communities, exceeding totals for each of the past five years
- **22,454 new clients** receiving information on health insurance, access and benefits, exceeding the target by 748%
- **104,671 new clients** participating in health education programs, exceeding target by 1,047%

Statewide Reentry Meeting

Community Reentry Project hosted the biannual Statewide Teleconference Reentry Meeting in Chicago and Springfield on January 23, 2020. The goal of this meeting was to increase the number of organizations that are aware of reentry services and to enhance the reentry services provided by community-based organizations and local health departments. A combined total of 45 participants were in attendance and discussed topics such as the <u>Sequential Intercept Model</u>, correctional telemedicine and release planning, and health policy updates.

Affirming and Inclusive Schools Task Force Report

In June 2019, Governor Pritzker signed an Executive Order to create the Affirming and Inclusive Schools Task Force. In February, this group delivered their completed <u>report</u> which details recommended practices for educators and administrators regarding school-based supports for transgender, nonbinary, and gender expansive students. PHIMC's Youth Engagement Manager Nat Duran served on this Task Force, and was recently interviewed about the report along with two other Task Force members on Illinois Public Radio's <u>The 21st Show</u>.

Youth Leadership Summit

The Alliance's annual Youth Leadership Summit was a smashing success! PHIMC extends deep gratitude to Ottawa Township High School for being gracious hosts to LGBTQ+ youth leaders and their adult supports from all across the state. Proviso Partners for Health

Community Wellness Hub in Maywood

<u>Proviso Partners for Health</u> (PP4H) continues planning for a Community Wellness Hub in the Village of Maywood. PP4H partnered with a volunteer team of urban planners from the

Illinois Chapter of the American Planning Association (APA-IL) to engage Maywood community members in visioning discussions about local entrepreneurship and community wellness. More than 30 residents, local entrepreneurs, and business owners who attended a summer workshop shared their ideas for growing Maywood's local economy and creating a community hub of opportunity for the Village.

<u>PP4H's summary report</u> captures community members' ideas, suggestions, and broad themes that will help guide next steps for the Community Wellness Hub.

Fall Summit

More than 60 PP4H coalition members, including community stakeholders, partners, and Maywood residents, attended the PP4H Fall Summit on November 15. The Summit featured updates on PP4H program hubs: Food Justice, School Wellness, Smart Routes to School, Community Leadership Academy, and Anti-Vaping, as well as keynote presentations on adolescent mental health awareness and an analysis of video gambling in Illinois.

Also at the Summit, PP4H facilitated roundtable discussions with coalition members, residents, and business owners to further explore a mix of local retail and business ideas, entrepreneurial opportunities, and nonprofits that promote health and wellness. The PP4H team will draw on these ideas in ongoing concept development plans for the Community Wellness Hub.

Commercial Property Tax Reform in Maywood

PP4H is devoting attention to Maywood's disproportionately high commercial property taxes, which pose a serious deterrent to local economic development. Residents who participated in the PP4H Wellness Hub Workshop raised concerns that inflated commercial taxes are a longstanding structural barrier to attracting new and supporting existing community businesses. PP4H is working with ChangeLab Solutions on strategies to address inequitable residential and commercial property tax assessments that would better position Maywood's depressed and vacant downtown as business-friendly and affordable to local entrepreneurs.

Forbes Nonprofit Council

PHIMC's Deputy Director of Finance, Donna Blackwell, was accepted into the Forbes Nonprofit Council on December 23, 2019. The Council is an invite-only, fee-based organization primarily for senior level executives in successful nonprofit organizations. Members are selected based on their "depth and diversity of experience," according to Forbes Nonprofit Council.

Donna came across an announcement for the Forbes Nonprofit Council while reading articles in Forbes and started the application process in early November. Once she completed the final phone call, she received an acceptance email. She is excited

HIV Prevention: Region 8

In December, PHIMC's sixteen Region 8 partners and program staff met at Aunt Martha's Health and Wellness in Park Forest for their second quarterly provider meeting. They reviewed the most recent data on HIV incidence and prevalence in the Region, shared best practices for recruiting and engaging specific populations via social media and for diversifying the HIV workforce through peer hiring, and were trained on use of the Determine TM HIV test kits.
