#### **COVID Youth Survey: Chicago**

Chicago Department of Public Health (CDPH) has seen persistent high case incidence of COVID-19 in young adults (18-29) over the past few months. To help inform policy decisions and response, CDPH seeks a better understanding of individuals in this age group, including behaviors and attitudes toward COVID-19. In pursuit of this, the CDPH epidemiology team has developed an anonymous youth survey for individuals 18-29.

It takes about 15 minutes to complete, and is publicly accessible here.

The survey does not request any personally identifiable information and its results will be aggregated for analysis.

If you are a young person in Chicago between the ages of 18 and 29, please consider taking this survey. Please also share this survey with your networks, to help slow the spread of COVID-19 in Chicago and keep Chicagoans safe.

# Diversity, Equity, and Inclusion Trainings: Under Attack

You have likely heard about the executive order which bans diversity, equity, and inclusion (DEI) trainings supported by federal funds. Many organizations and individuals in the public health and non-profit sectors have spoken out against this order, PHIMC among them, in an effort to avoid rolling back progress we have collectively made.

On October 5, 2020, Nonprofit Quarterly published <u>How Nonprofits Can Stop Trump's Effort to Roll</u> <u>Back Diversity Training</u> by Tim Delaney and David L. Thompson. The article explains:

"Since the beginning of September, the White House has unleashed a barrage of orders and instructions designed to disrupt the views of mainstream America that being informed about racial and gender diversity, equity, and inclusion is essential to the healing and well-being of the country and important for high-performing organizations."

They go on to describe what the executive order covers, what's at stake, and anticipated legal challenges, and they conclude with advice on "Moving beyond Outrage to Action." <u>Read the full article here</u>.

We invite you to also read the statement by PHIMC President & CEO Karen A. Reitan, <u>To Combat Race</u> and <u>Sex Stereotyping</u>, we reject this executive order, if you have not already. In it, she says:

"There has long been consensus in the public health community that entrenched and systemic racism is a driving force behind the majority of America's public health crises . . . Everywhere we look, we see the impact of bigotry in opportunities denied, communities neglected, potential unrealized, and lives lost."

"Teaching people not only to understand the impact of institutionalized racism and oppression, but also how to combat it is not anti-American. It is, in fact, one of the most pro-American things we can do."

# HIV Prevention in Suburban Cook County

In July, PHIMC launched a new Regional Implementation Group (RIG) for Region 8 program year with <u>fifteen partners</u> who provide critical, high-impact HIV prevention services throughout suburban Cook County. Three new partners joined the Region 8 team this year: Chosen Family Network, Greater Elgin Family Care Center, and Kenneth Young Center. Together, they provide risk-based and routine HIV testing, evidence-based risk reduction interventions for people vulnerable to or living with HIV, and distribution of safer sex supplies in west and northwest suburban Cook County. Our returning RIG 8 partners continue to innovate and implement strategies for community engagement and high-quality service delivery during the challenging COVID-19 context.

To support Illinois Department of Public Health (IDPH) while they focused on COVID-19, PHIMC partnered with Illinois Public Health Association (IPHA) to step in and lead a virtual four-day HIV testing training for 20 participants across Illinois. The training covered how to conduct client-oriented testing sessions, manage informed consent and confidentiality, provide health education, discuss risk reduction strategies, conduct the test and deliver results, and offer guidance on follow-up plans, including relevant referrals and linkages to further prevention or treatment.

Thank you to PHIMC staff Whitney Allen and Bryan Gooding and our amazing partners at IPHA for making this happen, and a hearty congratulations to all the newly-certified HIV test counselors!

Action Camp 2020

Although now over three months ago, Illinois Safe Schools Alliance is still flying high over the success of virtual Action Camp. Created in partnership with <u>Youth Services of Glenview/Northbrook's Pride</u> <u>Youth Program</u>, Action Camp is the largest LGBTQ+ youth leadership event in Illinois and typically includes up to 65 rising 8th through 12th grade students from across the state for a five-day sleepaway camp. Although this year looked different due to COVID-19, we worked to move Action Camp into the virtual realm while ensuring that our core programming remained -- as always -- determined, developed, and facilitated by young people.

PHIMC Youth Engagement Manager, Nat Duran, and Youth Services Pride Director, Lizzy Appleby - who co-direct Action Camp - were honored by the opportunity to present about this successful program pivot at <u>GSA Network</u>'s National Association meeting in September.

Nat is also thrilled to have started this school year off strongly with a new cohort of Youth Committee members, who inform the Alliance's youth leadership programming through peer education opportunities. They hosted their first event of the year, a National Coming Out Day webinar, for students in grades 7-12, on Sunday, October 11. Coming off of the success of Action Camp, the group

is excited to jump into the planning cycle for their first ever virtual <u>Youth Leadership Summit</u> in January 2021.
